-Old Bethpage Village (Old Bethpage, NY), Saturday, October 15: This idyllic, restored 19th Century village provides the setting for a timeline living history event. -Hope Lodge, PA (Fort Washington, PA), Saturday, November 5: This an annual event located on an 18th Century farmstead outside of Philadelphia. This year organizers reduced the event to one day, but are permitting participants to stay over on Saturday night. Keith Spaar will open his camp kitchen for attendees. The drums of war once more called HM 23rd Regiment of into battle, this time in central New Jersey. A strong rebel force emplaced itself, including artillery atop a commanding hill. The 23rd along with the rest of the Second Battalion secured the right flank of the line. After hastily forming with a composite company of the 22rd and 54th on the Fusiliers left and a Hessian detachment on the right, the Regiment began its up hill fight. The infantry received support from two guns and advanced aligned with the carriages axel to avoid being caught in cannon fire. The 23rd advanced with the Hessians and guns, all

three units working in unison. RSM Astle did a fine job emploring the firing line to keep up a brisk and paced fire. The rebels put up a stout resistance from their defensive positions. As the red line neared the crest of the hill, troops fixed bayonets and began an orderly and rapid advance towards the disintegrating rebel line. The speed of the Fusiliers advance was rewarded with the capture of three enemy field pieces.

Sunday Mars did not smile so fondly on the 23rd. The battalion assembled in a heavily forested ravine when rebel skirmishers and riflemen attacked. Fusiliers fought in pairs from tree to tree as proficiently as they would in a flat open field. The rebels were soon driven from the woods into a clearing and up a small hill. The 23rd immediately went to open order and advanced by ranks up the hill and kept up a constant, rolling fire at the enemy. The battle tilted back and forth as units advanced to fire or retired due to the heavy enemy fire. Once more, the British Brigade regrouped at the bottom of the hill and fixed bayonets. The charge was precise, all ranks neatly dressed and muskets leveled. The line covered considerable ground until confronted with a long line of rebel muskets and rifles, hidden on the reverse slope. On command, the rebel line erupted all at once with fire, smoke and the explosion of powder. Many of the Fusiliers did not survive the storm of lead and soon Major Loane, the commanding officer asked for terms. Throughout the chaos and confusion of the battle, Lance-Serjeant Urwin steadied his men and directed the firing line.

In addition to the fighting, Private Keith Spaar of the Grenadier Company generously provided meals, drink and a dining fly to give the weary troops a place to rest and eat. One of the highlights of the weekend was placing two new recruits from the Grenadier Company into the line: Greg Pohorecki and Mike Boyle. Recruit Glenn Thomas stopped by the camp and is in the process of joining Capt. Grey Grove's Company. It's always nice to see new faces in the ranks. Please welcome these gentlemen when you meet them

Additional Notes: One aspect that stood out during this event was use of the hour long battalion drill. Instead of parading the Colours or conducting the Manual Exercise, the officers and senior NCOs focused on tactical and practical applications and maneuvers. These included: advancing by file, open order and advancing by rank. This increased the speed with which units could deploy from column into a line of battle. On Sunday the entire battalion conducted a rehearsal in the woods, practicing fighting from tree to tree. I sent a note to Brigadier McGaughey requesting that we follow this training pattern at future events. Conducting realistic tactical exercises may encourage more of our members to attend events.

The 23rd participated in annual event at Germantown, marking Mr. Washington's failed attempt to destroy the Light Infantry units garrisoned there. The 23rd combined with the Grenadier Company of the 42rd Regiment of Foot formed a composite Grenadier Battalion, responsible for securing the right flank of the Crown line. The Battalion performed well, fighting a delaying action while the rebel army deployed and then retiring to the grounds of the Chew Mansion in the face of the growing enemy force. After allowing the rebels a number of futile attacks against the stalwart, stone house, the force reformed on the sides of the house and proceeded to drive the rebels back. After trading volleys and faced with the cold steel fixed on Crown muskets, rebel commanders asked for terms and put an end to the slaughter.

The men of the 23rd performed will. In particular, RSM Astle did an excellent job of running the firing line, allowing Major Reilly to work with Major Loane, HM 43rd Regt. of Foot and Capt. MacWilliam, 42rd Regiment of Foot in executing the plan of battle. With each event, the tactical capabilities of the 23rd are improving, allowing more flexibility and speed prior to and during the battle. For example the 23rd advanced rapidly during the opening stages of the battle and moved into a position to refuse the right flank. This maneuver forced the rebels to uncoil their column more quickly than they wanted to and ensured the security of the right side. Later, after advancing from the right side of the house, a gap opened between the Grenadier Battalion on the right and the 43rd Regt of Foot in the center. The Grenadiers moved to open order to extend the front and eliminated the gap. The men of the 23rd did an excellent job!

Off the field, the RWFIA received an invitation from the Royal Welsh in Wales to contribute an article to *Y CYMRO* (The Welshman)—The annual Regimental journal. Thanks to the command and staff, namely Greg Urwin who helped draft the article. The journal should be published in the March timeframe. This is another example of strengthening the bond with our Comrades across the Atlantic.
