## June 24-25, Battle of Short Hills (Oak Ridge Park, Clark, NJ):

Uniform: Early War Kit, including full gaiters and wig. Pack at least 60 cartridges for two battles. I am still working the feeding plan and should have more information shortly.

This event is a recreation of a June 1777 action fought when Sir William Howe's Army attempted to trap Mr. Washington's force. Gen. Howe's plan almost worked, but the hard fighting of a New Jersey Brigade allowed the Continentals escape the trap. *This is the last site event before it is redeveloped into a municipal park*. "All,

The event went well despite the rain. Grenadiers Alex Ivanchishin, Keith Spaar, as well as Drum Major Joe Siegel and acting Brigade SgtMaj Steve Raby were in attendance.

Keith Spaar set up his kitchen and we had excellent meals for Saturday and Sunday. We had a steady stream of visitors to our camp site attracted by our impressive fire.

Saturday was a bit rainy - the morning battle was cancelled but the rain stopped for two hours and we were able to march out and meet the Americans. The crowd was small and the muskets didn't fire that well but we still managed to force the Americans from the field.

We had an unexpected visitor to our camp on Saturday - Tom Reinhart stopped by with his wife and daughter and many stories were told of old battles and other frivolities.

Saturday evening the Mount Vernon staff provided strong drink, sweets and other rations as well as fireworks for both armies.

Sunday turned out to be a beautiful day for a battle and we marched out and met the Americans again - in the morning we forced the Americans off the field but in the afternoon the rebels took the day. The crowds were much larger and heartily enjoyed the performance.

Overall a great event - highly recommend everyone to make the effort to attend."

## Reenlistment for the Conflict in America

One of His Majesty's most distinguished Regiments is offering you the opportunity to obtain honour and glory known only to the 23<sup>rd</sup> through noble service in the present conflict. The term of this contract is for one year and encompasses supporting Army and Regimental operations throughout the troublesome 13 Colonies.

Each Fusilier is expected to help fund the Regimental treasury through the payment of Regimental dues of **\$20.00**; which does not include Company Fees. An addition fee of \$25.00 is required for membership in the Brigade of the American Revolution.
