

historic discovery was announced on Veterans Day by the South Carolina Battlefield Preservation Trust (SCBPT). Archeologists and forensic scientists were called in to survey the site. They believe that 12 of the bodies are Continental soldiers from either Maryland or Delaware, one is likely a NC Loyalist and one served with the 71<sup>st</sup> Regiment of Foot, Fraser's Highlanders. The British Embassy was informed of this discovery and I'm told the British Parliament was briefed on it as well. Planning is underway by the SCBPT, Camden area partners and the US Army for re-interment ceremonies from 20-22 April, 2023 in Camden.
